

Atlas Affiliate Program — Terms of Service

Effective Date: April 9, 2026

1. Overview

These Affiliate Program Terms of Service ("Terms") govern your participation in the Atlas Affiliate Program ("Program"). By participating in the Program, you ("Affiliate") agree to be bound by these Terms. Atlas reserves the right to modify these Terms at any time, with changes taking effect upon posting.

2. Eligibility

To participate in the Program, you must:

- Be a registered Atlas account holder in good standing.
 - Be of legal age in your jurisdiction to participate in cryptocurrency trading activities.
 - Not be in violation of any Atlas platform terms, policies, or applicable laws.

3. How the Program Works

As an Affiliate, you will receive a unique referral link tied to your Atlas account based on your claimed username. When you share this link and a new user registers and meets the qualifying conditions below, you will earn a referral reward.

4. Referral Reward

- **Reward Amount:** \$5 USD (credited as an airdrop to your Atlas account)
- **Reward Currency:** Credited in the equivalent value to your Atlas account balance

- **Payout Method:** Airdrop directly into your Atlas account

5. Qualifying Conditions

A referral is considered **successful** and eligible for a reward only when **all** of the following conditions are met:

1. The referred user registers a new Atlas account using your unique referral link.
2. The referred user makes a **minimum deposit and trades \$10 USD** (or equivalent in cryptocurrency) from their Atlas account.
3. The referred user's account, deposit and trade are verified and approved by Atlas.

Self-referrals, duplicate accounts, or fraudulent referrals will not qualify and may result in account suspension.

6. Reward Disbursement

- Rewards will be airdropped into your Atlas account following confirmation of a successful referral.
 - Atlas aims to process reward airdrops within **14 business days** of the referral campaign period ending
 - Atlas reserves the right to delay or withhold rewards pending fraud review or compliance checks.

7. Prohibited Activities

Affiliates may not:

- Create fake or duplicate accounts to generate fraudulent referrals.
- Use spam, misleading advertising, or deceptive practices to acquire referrals.
- Misrepresent Atlas, its products, or the terms of the Affiliate Program in any way.
- Offer unauthorized incentives or promises to referred users on behalf of Atlas.

- Violate any applicable local, national, or international laws in connection with the Program.

Violation of any prohibited activity may result in immediate disqualification from the Program, forfeiture of pending rewards, and/or termination of your Atlas account.

8. Program Modifications & Termination

Atlas reserves the right, at its sole discretion, to:

- Modify, suspend, or terminate the Affiliate Program at any time.
- Change the reward amount or qualifying conditions with reasonable notice.
- Disqualify any Affiliate found to be acting in bad faith or in violation of these Terms.

Any rewards already confirmed and airdropped prior to program termination will not be affected.

9. Taxes

Affiliates are solely responsible for reporting and paying any taxes applicable to rewards received through the Program. Atlas does not provide tax advice. Please consult a qualified tax professional regarding your obligations.

10. Limitation of Liability

Atlas shall not be liable for any indirect, incidental, or consequential damages arising out of or related to your participation in the Affiliate Program. The total liability of Atlas under this Program shall not exceed the total rewards paid to you in the three (3) months preceding a claim.

11. Governing Law

These Terms shall be governed by and construed in accordance with applicable laws. Any disputes arising under these Terms shall be resolved through binding arbitration or in a court of competent jurisdiction, as determined by Atlas.
